#### WHO SHOULD ATTEND?

Delegates participate in an introductory virtual classroom tutorial, undertaken via Microsoft Teams, where the key principles of the course will be discussed. Depending on the course, there may be other webinars to complement the online learning. The introductory webinar introduces the learners to their tutor, and each other, just as a classroom training session would.

The webinars will:

- Outline the overall aims and objectives of the course.
- Outline the role that IOSH training plays in improving the understanding of health and safety in the workplace.
- Outline the key elements of the course.
- Provide an opportunity for delegates to discuss the specific context in which they are operating, and to review health and safety issues that are relevant to their organisation and their roles within it.
- Show delegates how to access online course resources.
- Outline how delegates can make the best use of their time when completing online course resources.
- Give some pointers as to how best to complete the end assessment/assignment, depending on which course they are undertaking. (Please note: these are an integral part of the course and a requirement of IOSH.)

Webinar duration is generally between one and three hours, depending on the course.

Following the introductory webinar, learners then complete the online course and resources via our award-winning online learning platform. You will be given a time period during which you are encouraged to complete the resources. You are advised to take time to reflect on how these elements relate to your role and your organisation.
